Justice and Public Safety Cabinet Title VI Implementation Plan 2010 Annual Update

I. GLOSSARY:

The Justice and Public Safety Cabinet submits its annual compliance status report and update for its Title VI of the Federal Civil Rights Act of 1964 Implementation Plan pursuant to KRS 344.015 and 45 KAR 1:080. The Title VI Coordinator and primary contact for the Justice and Public Safety Cabinet is Tina Moss, Staff Assistant, State Office Building Annex, 2nd Floor, 125 Holmes Street, Frankfort, Kentucky 40601, (502) 564-7554 X230. (45 KAR 1:080 Section 4(4) update). The Justice and Public Safety Cabinet updated Sections 1, 2, 3, 4, 5, 6, 7, 8, 9, 10, 11, 12 and 13 of 45 KAR 1:080 in this report including information on the department’s Limited English Proficiency (LEP) issues in order to take responsible steps to ensure meaningful access to agency programs and activities by LEP persons.

II. OVERVIEW:

With close to 8,000 employees, the Kentucky Justice and Public Safety Cabinet (JPSC) is the second largest agency in state government.

It is the state entity responsible for criminal justice services, which encompasses law enforcement activities and training; prevention, education and treatment of substance abuse; juvenile treatment and detention; adult incarceration; autopsies, death certifications and toxicology analyses; special investigations; paroling of eligible convicted felons; and long range planning and recommendations on statewide criminal justice reform issues.

As a national leader in criminal justice, the Justice and Public Safety Cabinet's vision is to continuously improve public safety and the quality of life.

The Cabinet accomplishes its mission through direct services for planning, program operation, monitoring and evaluation, and resource management. The Cabinet consists of the following organizational units:

- **Office of the Secretary**

The Office of the Secretary directs and carries out the mission and goals of the Cabinet.

- **Office of Investigations**

The mission of the Office of Investigations is to serve the citizens of the Commonwealth of Kentucky by receiving and investigating certain limited allegations involving abuse of juveniles committed to, or in the custody of, the Department of Juvenile Justice and investigating administrative violations within the Justice and Public Safety Cabinet as determined by the Cabinet Secretary.

- **Grants Management Branch**

The Grants Management Branch (GMB) administers federal and state funds to local communities. The GMB receives approximately \$15-18 million on an annual basis from various federal grant programs and approximately \$18 million from the American Recovery and Reinvestment Act of 2009 to distribute to state and local criminal justice agencies and not-for-profit service providers. These funds are disbursed through grant programs. Each competitive grant program has its own objectives, allowable uses of funding, matching and eligibility requirements. The GMB also adheres to specific policy priorities as set forth by the Commonwealth of Kentucky.

- **Office of the Parole Board**

As part of the Criminal Justice System, The Kentucky Parole Board is committed to the safety and protection of all citizens of the Commonwealth by rendering fair and impartial release and revocation decisions which serve the best interest of the public, crime victims and those who are otherwise defenseless against the criminal element of our society. The Kentucky Parole Board grants and revokes parole for adult felony offenders incarcerated in Kentucky correctional institutions. The Parole Board is attached to the Cabinet for administrative purposes only.

The Parole Board further promotes the successful reintegration of the criminal offender into the community and supports their successful attempts to avoid recidivism.

- **Office of the Kentucky State Medical Examiner**

Recognized as national leaders in their respective fields, the Kentucky Office of the State Medical Examiner staff assists Kentucky coroners in all aspects of death investigations by

determining the cause and manner of death and identification of the deceased. They perform autopsies, annually conduct nearly 2,500 autopsies at offices located in Louisville, Frankfort, Madisonville and Ft. Thomas. Also, 250 examinations of living individuals, 90 percent of whom were children and may have sustained physical injury, were conducted to assist law enforcement or social services entities in investigations.

- **Office of Drug Control Policy**

The vision of the Office of Drug Control Policy is to lead the nation in ensuring a united effort among prevention, treatment, education and law enforcement initiatives to address drug abuse in Kentucky.

- **Department of Public Advocacy**

Under KRS Chapter 31, Department of Public Advocacy (DPA) is responsible for representing all indigents charged with a crime, those proceeded against under KRS Chapter 202A (Kentucky's involuntary commitment process), and those prosecuted for civil contempt pursuant to *Lewis v Lewis, Ky., 875 S.W2d 862 (1993)*. Each year, DPA's criminal specialists handle over 140,000 trial and post trial cases statewide, including DUI cases, involuntary commitment cases, juvenile cases, and demanding, complex and difficult cases involving sex abuse, and cases where death is sought as the penalty. The DPA is organized into four divisions. Trial, Post Trial, Law Operations, and Protection and Advocacy.

- **Kentucky State Police**

Since being established in 1948 by act of the Legislature of the Commonwealth of Kentucky, the Kentucky State Police has defined itself as a professional, detailed and efficient law enforcement agency dedicated to preserving law and order for the protection of its citizens. Kentucky State Police is responsible for highway safety and traffic control, detects and prevents crime, apprehends criminals, and maintains law and order throughout the state.

- **Department of Juvenile Justice**

The Kentucky Department of Juvenile Justice's mission is to improve public safety by providing balanced and comprehensive services that hold youth accountable, and to provide the opportunity for youth to develop into productive, responsible citizens.

The Department's vision is to be an organization of well-trained professionals dedicated to the positive development of youth who contribute to safe and caring communities.

- **Department of Criminal Justice Training**

The Department of Criminal Justice Training (DOCJT) is a nationally recognized agency that provides state-of-the-art training to law enforcement officers in Kentucky. The DOCJT provides entry-level and professional-development training for approximately 12,000 students each year, including city, county, airport and state university police officers, sheriffs, deputy sheriffs, coroners and law enforcement telecommunicators. DOCJT also offers training to officers from other state and federal agencies.

The primary mission of the Department of Criminal Justice Training is to provide quality

training and improvements to the criminal justice system to advance the delivery of law enforcement services in Kentucky.

- **Department of Corrections**

The Department of Correction's mission is to protect the citizens of the Commonwealth and to provide a safe, secure and humane environment for staff and offenders in carrying out the mandates of the legislative and judicial processes; and, to provide opportunities for offenders to acquire skills which facilitate non-criminal behavior.

III. SCOPE APPLICABILITY:

The Kentucky Justice and Public Safety Cabinet re-affirms its policies to afford all individuals the opportunity to participate in federally financially assisted programs and adopts the following provision:

“No person in the United States shall, on the grounds of race, color, or national origin, be excluded from participation, be denied the benefits or, or be subjected to discrimination under any program or activity receiving federal financial assistance.”

The overall responsibility for complying with the provisions of Title VI is vested in the Secretary, Kentucky Justice and Public Safety Cabinet, who is accountable for the administration of the Kentucky Justice and Public Safety Cabinet and its organizational units, contracting agencies, and sub-grantees of Federal programs administered within the Justice and Public Safety Cabinet.

The Justice and Public Safety Cabinet will not on the grounds of race, color, or national origin directly or through contractual or other arrangements:

- Deny any individual or group any service, financial aid, or other benefit provided under any program;
- Provide any service, financial aid, or other benefit to an individual or group in a different manner from that provided to others under the program;
- Will not discriminate against an individual or group who receives financial aid, or other benefit under any program;
- Restrict any individual or grouping any way in the enjoyment of any advantage or privileged enjoyed by others receiving any service, financial aid, or other benefit under any program;
- Treat an individual or group differently from others in determining whether he satisfies any admission, enrollment, eligibility, membership or other requirement or condition individuals must meet in order to be provided any service, financial aid, or other benefit under the Cabinet's program's;
- Adopt methods of administration which would limit participation by any individual or group of recipients of any programs;
- Deny any individual or group the opportunity to participate as a member of a planning or advisory body which is an integral part of a program.

In addition, Executive Order 13166 requires that recipients of federal funds provide “meaningful access to people who speak limited English.” To assure

meaningful access to the Cabinet's programs, the following steps have been taken:

- The Office of the Secretary provides no direct client services. For translation of languages, Office of the Secretary staff would access subordinate agencies' language services. When fully developed, our single community-access web portal (electronic grants management system) will have link to electronic translation services.
- The Department of Public Advocacy serves the Commonwealth's citizens who are unable to afford legal representation regardless of race, gender, religion or language needs. A sector of our client population speaks/understands limited English.

The Administrative Office of the Courts (AOC) provides interpretive services in a court room proceeding. Additional services are necessary to meet client needs beyond the courtroom. Currently, the need for interpreters/translators is met by petitioning the courts for interpretive services. The Department of Public Advocacy is considering more viable alternatives to assure client needs are met at a high level.

- The Kentucky State Police With the inclusion of the LEP in every client's treatment plan, there is no need for an agency-wide plan to address the issue. Vehicle Enforcement within Kentucky State Police provides programs and activities directed at commercial vehicle regulation and safety. Commercial drivers are required to speak English sufficiently "to respond to official inquiries". According to CFR 398.3 (in part):

“(c)(4) Knowledge of English. Every driver shall be able to read and speak the English language sufficiently to understand highway traffic signs and signals and directions given in English and to respond to official inquiries.”

- The Department of Juvenile Justice with the inclusion of the IEP in every client's Treatment Plan, there is no need for an agency-wide plan to address this issue.
- The Department of Criminal Justice Training (DOCJT) consists of Law Enforcement professionals from across the Commonwealth. DOCJT provides entry-level and professional-development training for approximately 12,000 students each year, including city, county, airport and state university police officers, sheriffs, deputy sheriffs, and telecommunicators. KRS 95.440 requires police officers in urban-county governments and 2nd and 3rd class cities to speak English. KRS 95.710 requires officers of 4th and 5th class cities to speak English. Because of these legislative requirements DOCJT has not encountered a student/client with limited English proficiency. In addition, Melissa Beck of the Kentucky Law Enforcement Council Office of Peace Officer Professional Standards (POPS), administer of the certification process for peace officers

statewide, reports they have received no requests for testing in a language other than English. With a zero frequency of contact with clients of limited English proficiency the DOCJT has not developed client programs to address LEP.

- ✓ To aid in possible contact with persons other than clients with LEP the agency annually surveys all employees to identify languages spoken plus proficiency level. New employees complete the survey as a part of orientation so that the posting can be updated as appropriate. Currently identified language proficiencies within DOCJT are: American Sign Language-novice (2); Dutch-good (1); German-good (1), novice (4); Japanese-novice (1); Spanish- fluent (1), good (1), novice (4); Vietnamese-proficient (1); French (1) novice. These results, with employee contact information, are available to all agency employees on a shared network drive.
 - ✓ The POPS office has been requested to inform this office if they ever receive a request for accommodation based on language so that appropriate action can be taken to prepare for that student if they pass the screening process.
- The Department of Corrections with the inclusion of the LEP in every client's treatment plan, there is no need for an agency-wide plan to address the issue.

IV: RESPONSIBLE OFFICIAL:

The responsibility for complying with the provisions of Title VI is vested in the Secretary of the Kentucky Justice and Public Safety Cabinet, who is responsible for the administration of the Justice and Public Safety Cabinet, Office of the Secretary, Department of Public Advocacy, Kentucky State Police, Department of Juvenile Justice, Department of Criminal Justice Training, and the Department of Corrections. Each department within the Justice and Public Safety Cabinet and each sub-grantee shall assign a Title VI Coordinator who will have the responsibility for administering the Title VI compliance and complaint procedures for their respective departments.

V: STATEMENT OF ASSURANCE:

The Justice and Public Safety Cabinet obtains a contractual commitment and assurance from each sub-receipt that the contractor does not and will not discriminate on a prohibited basis and complies with all laws including, but not limited to, Title VI of the Civil Rights Act of 1964 and all implementing regulations and executive orders.

The Cabinet has provided the required assurances to providers of federal financial assistance for fiscal year 2010-2011 and for upcoming fiscal year 2011-2012. Also, through contracts and regulations, the Cabinet has bound contractors, vendors, and all other Cabinet sub-recipients to comply with all applicable law.

VI: ID PROGRAM UNDER TITLE VI:

Each Justice and Public Safety Cabinet agency and administrative body that was a recipient of federal funds fiscal year ending June 30, 2011 shall comport with the provisions of this plan to ensure that no person on the basis of race, color, or national origin, shall be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any of its programs and activities receiving federal financial assistance. 45 KAR 1:080 Section 4(6) requires an identification of programs or activities subject to Title VI. 5. Department of Criminal Justice Training (54-525)

VII. COMPLAINT PROCEDURES:

A Title VI complaint alleging discrimination on the basis of race, color, or national origin may be filed according to the following procedure.

a. How to file a complaint.

A complaint alleging discrimination against the Kentucky Justice and Public Safety Cabinet, Department of Corrections, Department of State Police, Department of Juvenile Justice, Department of Criminal Justice Training, Department of Public Advocacy, sub grantee, or contracting agency may be filed as an internal or as an external complaint, i.e., the complaint may be filed with the sub granting agency, Department Coordinator, Justice and Public Safety Cabinet Coordinator, or at the Kentucky Human Rights Commission.

b. Where to file a complaint.

Complaints must be filed in writing, preferably on Kentucky Justice and Public Safety Cabinet form (attachment A). The form can be filled out by the complainant or by his/her representative, or by a local, Department, or Cabinet Coordinator. A copy must be sent to the Cabinet Title VI Coordinator, Kentucky Justice and Public Safety Cabinet, 125 Holmes St., State Office Building Annex, 2nd Floor, Frankfort, KY 40601-2108. A copy must also be retained in the files of the local or Department Coordinator. If the complainant is unwilling to complete the form, he/she may write, or have written, a letter stating the circumstances of the complaint. It must then be filled out by the Coordinator receiving the complaint and should be attached to the complainant's letter. The local or Department Coordinator has the primary responsibility for receiving, acknowledging and investigating complaints and for reporting the findings. The local or Department Coordinator will notify the Justice and Public Safety Cabinet Coordinator as soon as a complaint is filed and when a final disposition is rendered.

c. Time for processing a complaint.

A complainant shall have 30 days to file a complaint after the alleged discrimination occurred. If a complainant wishes to appeal a finding on the proposed remedial action by the agency, he/she should file an appeal to the Kentucky Justice and Public Safety Cabinet within 30 calendar days following receipt of the finding.

d. Withdrawal of Complaint.

The complainant may withdraw his/her complaint at any time during the process by notifying in writing the agency where the complaint was first filed or by notifying the Title VI Justice and Public Safety Cabinet coordinator or any department's Title VI coordinator.

VIII: COMPLIANCE/NONCOMPLIANCE REPORTING:

The Title VI Coordinator from each department is required to annually review the activities of the department to determine whether there is compliance with Title VI. The Title VI Coordinator will complete an annual Title VI Compliance Self-Survey and submit as part of the annual review and plan update required by KRS 344.015 to be submitted by July 1st of each year to the Auditor of Public Accounts and the Commission on Human Rights.

The Title VI Coordinator, with the approval of the Secretary, may direct a sub recipient to complete a Title VI self-survey or may initiate a compliance review prior to or after the award of any federal monies.

Any instances of noncompliance identified through any of the follow-up compliance reviews will be reported to the Title VI Coordinator. In reference to Section VII, efforts have already been initiated by the Title VI Coordinator to obtain full compliance voluntarily. Therefore, the Title VI Coordinator shall report the noncompliance to the Secretary of the Justice and Public Safety Cabinet with a recommendation for appropriate action.

IX: AGENCY TRAINING PLAN:

Employees of the Kentucky Justice and Public Safety Cabinet, Department of Public Advocacy, Kentucky State Police, Department of Juvenile Justice, Department of Criminal Justice Training and Department of Corrections and all sub grantees shall receive orientation regarding the obligations and rights involved in the Title VI Program. In-service training programs for all employees shall continually apprise staff of their responsibility to render a high quality of services to all beneficiaries regardless of their race, color, or national origin.

X: EVALUATION PROCEDURES OF PLAN:

The Justice and Public Safety Cabinet and its agencies receiving federal funds will measure its goals through the following activities. See attached forms.

- Annually utilize a self-survey, status report, and program review to determine compliance status. (See attached forms).
- Initiate corrective action within thirty (30) calendar days of identifying noncompliance.

The Kentucky Law Enforcement Council currently has minority representation. Executive Order 2006-805 specifies the voting members of the Kentucky Law Enforcement Council. The following are members by virtue of Office: the Attorney General of Kentucky; the Commissioner of the Department of Kentucky State Police; Director of the Southern Police Institute of the University of Kentucky; Dean of the College of Justice and Safety of eastern Kentucky University; the President of the Kentucky Peace Officers Association; the President of the Kentucky Association of Chiefs of Police; the Kentucky President of the Fraternal Order of Police; and the President of the Kentucky Sheriffs' Association. Remaining voting members are appointed by the Governor of the Commonwealth as follows: a city manager or mayor; a county judge executive; three (3) Kentucky sheriffs; five (5) chiefs of police; a member of the Kentucky State Bar Association; and a citizen of Kentucky not coming from within the foregoing classifications. In addition, a Federal Law Enforcement Liaison designated by a conference of the United States Attorneys for the Eastern and Western Districts of Kentucky shall serve as a non-voting member. The agency will seek to identify qualified candidates for consideration when requested by the appointing authority.
